Town Meeting to appropriate unspent 2016 Bond Funding Discussion and Action- Chris B opened up the discussion to say about 4 years ago, there was a special town meeting, where the public voted to allocate 2 million bonded funds to local road projects, which currently has \$184,468.09 as a remaining balance. The project was completed under the estimated cost. By talking to the bond council, it was determined that we can't use it in the specific nature of the resolution. There are two suggestions for the remaining funds.
 - a. One is to pay down the debt, but that wouldn't help our current road projects.
 - b. Two is under the current resolution, go to a town vote to give greater flexibility to the number of road projects. We would need to reallocate the funds to current road projects, such as to Skokorat Rd.

We currently have STEEP approved for Beacon Valley Road. A sample bond resolution was drafted to submit to the Board of Finance for consideration and vote to move forward with a town vote. The Board of Finance would have to vote on the course of action.

PB: Can we suggest that the Board of Finance include this in a special meeting to move the course of action forward?

CB: Does anybody have any further questions?
