Q: Will there be a solution for a downed fuel cell?

A: There will be a connection to the grid. They will also be connected to a natural gas generator.

## -B. Gilio, Bethany Rd.:

Q: Will any power generated be sold back to the grid? Or is it only serving the facility?

A: Their expectation is to serve the facility.

#### -E. Schwarz, Wolfe Ave:

Q: Timeline?

A: 1 ½ years of engineering and all phases would be complete in roughly 3 years.

## -K. Mcduffy, Bethany Rd:

Q: Volume of water needed to run fuel cell?

A: There are chillers needed to cool down the computers. There will be about half of the water needed to cool them. 32 megawatts roughly.

### -M. Fernandes Sharon Dr:

Q: Is there any downside to this project for the residents?

A: Other than the original sale price, no.
