- Test Pit Results
- Close to watercourse /pipe Needs to be flagged
- Swale Drawing
- Steep Elevation
- Storm Water Management Going to disturb lots of ground to set up septic system
- Need to put a swale across the top Suggestion to Town Engineer

Town Engineer's concerns:

- The site plan seems adequate for stormwater retention and S&E controls recommend a silt sack be installed in the CB in the driveway
- Erosion control matting be used on the slope to establish turf. If we get any significant rain events during construction the site will wash out.
- Needs to see reserve septic leaching area on plans
- Soil Scientist report is from 2007 Report should be updated
- Test pit findings and perc test results, which are necessary to confirm the proposed septic system is adequate.

SK: Horbal's office has 2016 Soil Scientist Report. Have them come out and flag existing wetlands and the pipe.
