## 2. Approval of TIP Amendments

- a. Project No. 0300-0202 New Haven Line Infrastructure Upgrades Mark Nielsen said Phase Three of the network infrastructure upgrades will use FTA Section 5307 funds to establish the fiber optic network infrastructure to support a new CCTV system at seven passenger stations (Noroton Heights, Darien, Rowayton, South Norwalk, East Norwalk, Westport, and Greens Farms) and on one moveable bridge (SAGA Bridge). This project will enhance security systems with improved surveillance methods to ensure the safety and security of the commuting public.
- b. *Project No. 0400-XXXX Cttransit Systemwide Bus Replacement* Mr. Nielsen explained that this project will use FTA Section 5307 and Section 5339 funds for the replacement of buses that have reached the end of their service life of 12 years or 500,000 miles. This project will replace buses purchased in 2004, 2005, and some in 2007 that currently operate in the Hartford and New Haven divisions of CTtransit.
