Turner Miller Group has compiled an assortment of demographic data for your review. This data was originally assembled by the Council of Governments of Central Naugatuck Valley (COGCNV) in their publication, *A Profile of the CNVR: 2009* and by the Connecticut Economic Research Center (CERC) in their publication, *2010 Town Profiles*, both of which have been attached.

Because the COGCNV report covers a number of communities, we have highlighted in yellow information directly related to the Town of Beacon Falls. In both reports we have underlined in green demographic information that exhibits a unique or interesting factor relevant to the Town of Beacon Falls. We summarize these interesting factors hereafter:

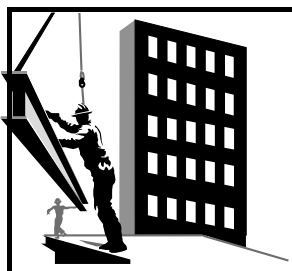
A Profile of the CNVR: 2009

- Pages 15-17 – The Town of Beacon Falls has the second lowest population in the Central Naugatuck Valley, but is also the smallest Town and is generally consistent with surrounding communities in population density.
- Pages 18-19 – Generally the population is predominantly white and not of Hispanic origin.
- Page 22 – Interestingly, the Town has a higher proportion of residents in the 25-34 age cohort (and the 25-49 age cohort) than the surrounding region, New Haven County and the State. This is somewhat unique for suburban communities and may demonstrate a supply of housing preferable to young adults.
- Page 23 – There is also a uniquely high ratio of non-family households in the Town.
- Page 26 – The household income distribution exhibits a higher than average preponderance of households earning in the \$35,000 to \$75,000 in 1999. This is a solidly middle to upper-middle income range.
- Page 27 – The Town exhibits a somewhat high number of persons living below the poverty level and is third highest in the region after the City of Waterbury and the Town of Naugatuck. This population is concentrated in the center of Town as exhibited on page 14.
- Page 28 – The Town has a higher than typical percentage of persons whose highest level of educational attainment is some college with no degree.
- Page 35 – In 2000 and 2008, the Town almost directly mirrored the unemployment averages for the State.
- Page 38 – Although not unique to Beacon Falls, it is relevant to note that there was a decrease in Total non-agricultural covered employment between the years of 2007 and 2008.
- Page 40 – Beacon Falls has a very high proportion of manufacturing employment.
- Page 49 – The Town has an above average number of housing units multifamily structures with more than 5 units and in mobile homes. This may be a potential cause of the uniquely high distribution of the 25-34 age cohort.
- Page 50 – Beacon Falls was ranked 31 of 169 Connecticut communities in new housing units constructed.
- Page 54 – Beacon Falls has a significantly lower number of assisted housing units than the region, County or State.
- Page 55 – The Town exhibited a higher vacancy rate for rental housing than the typical suburban community in the region.
- Page 56-59 - Between 1990 and 2000 the Town exhibited a decrease in the Median Value of owner-occupied housing and a significant increase in the Median Gross Rent. There was a corresponding higher degree of owner-occupied housing growth during the same period.

CERC Town Profiles:

- Town Residents pay lower than state average per capita taxes.
- The Town has a higher rate of indebtedness than the State average.
- The crime rate is significantly lower than the State average.
- Town Schools have higher than State average test scores.

Figure I-A1: CNVR Population by Municipality: 1990, 2000, 2008

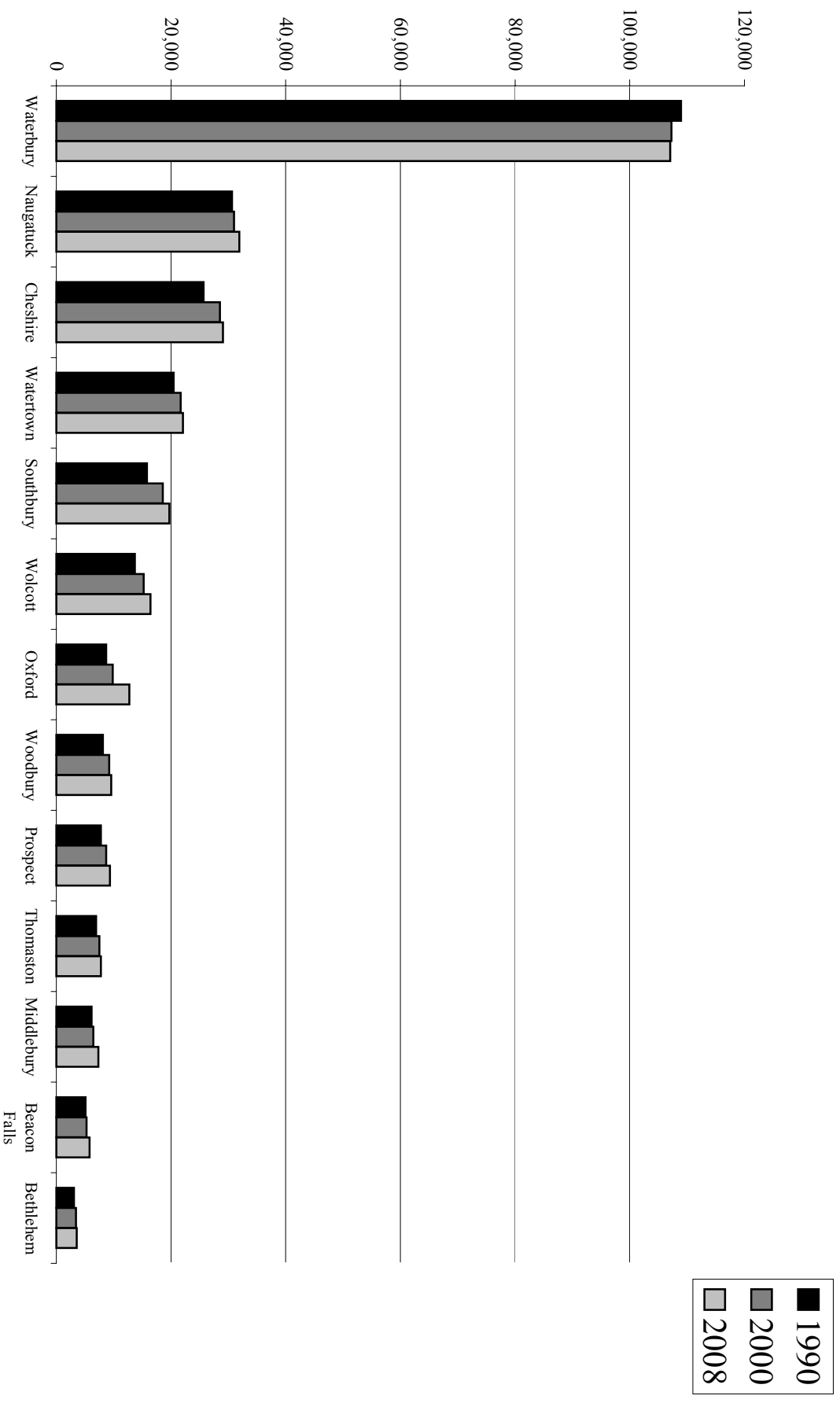
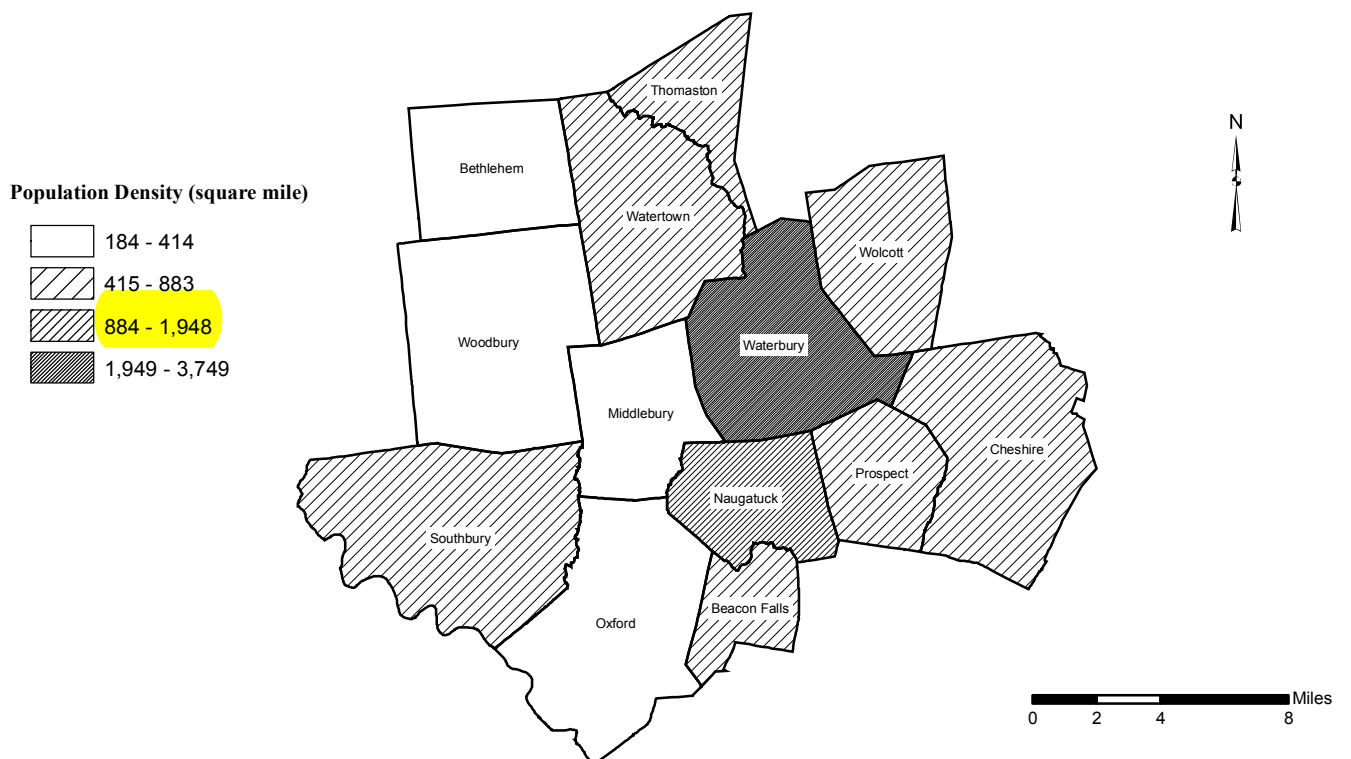


Figure I-A2. CNVR Population Change, by Municipality: 2000 - 2008



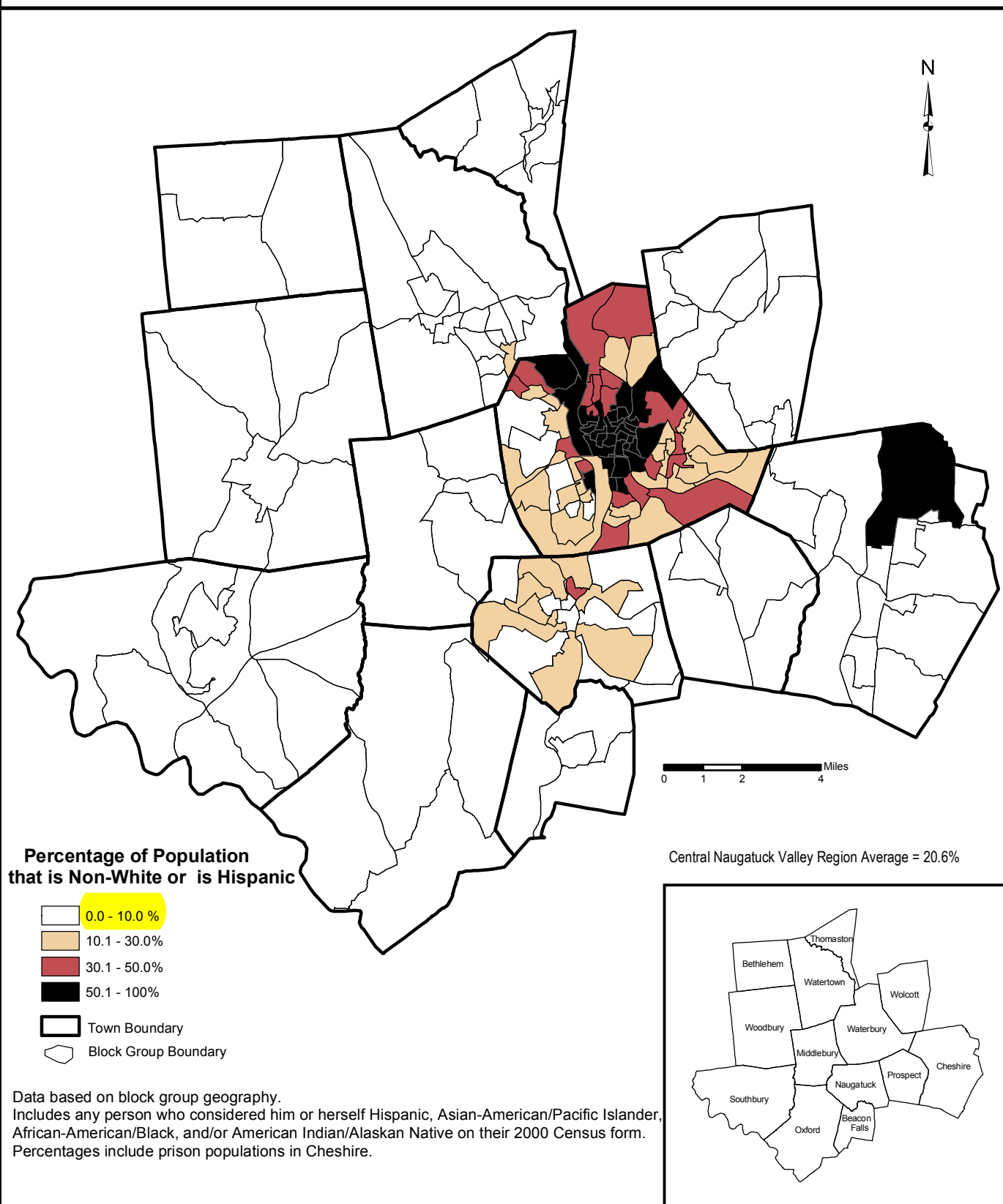

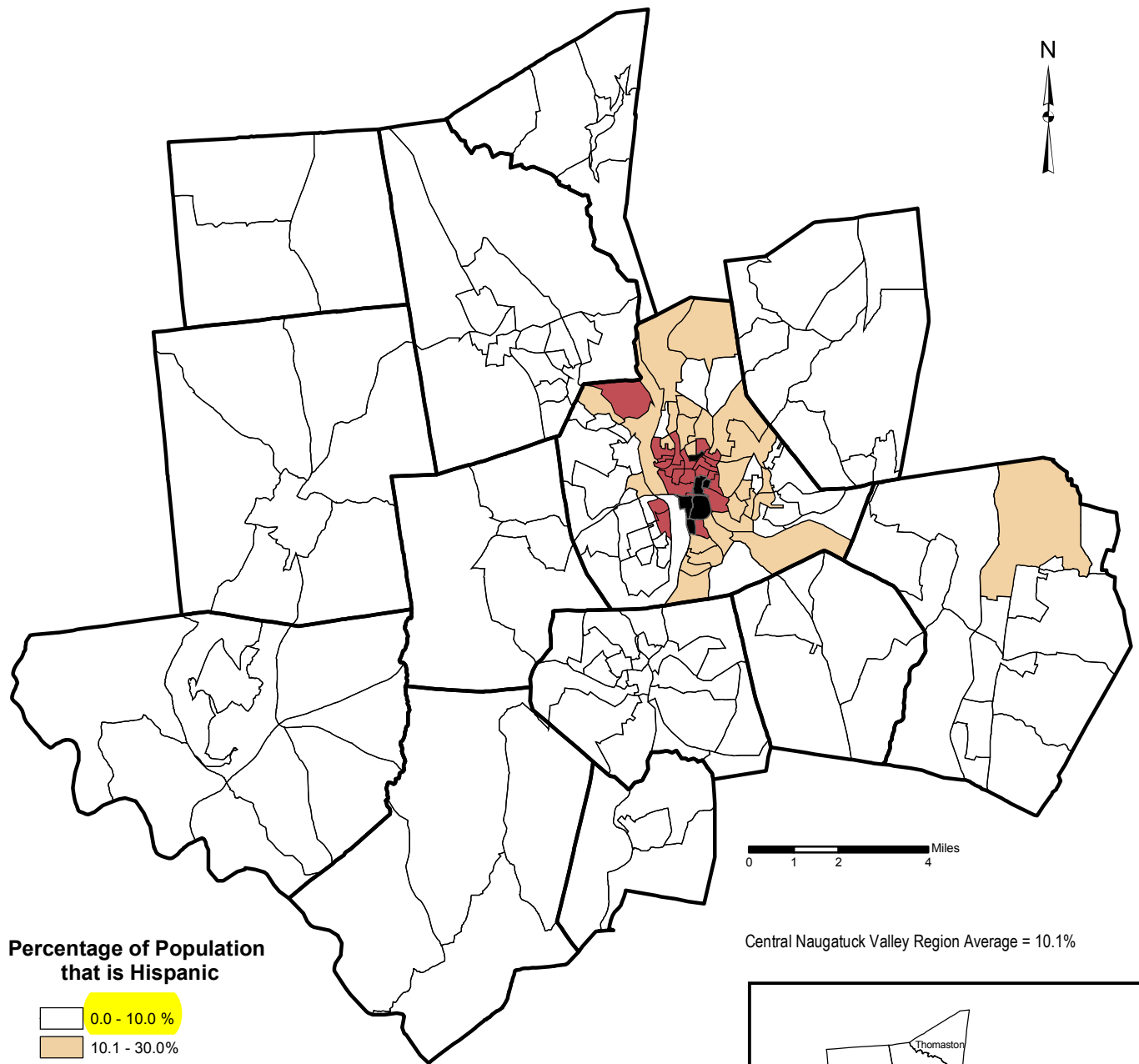
Figure I-C1. Minority Population, by Block Group: 2000



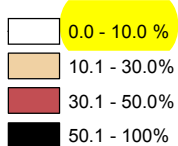

Percentage of Population that is Hispanic



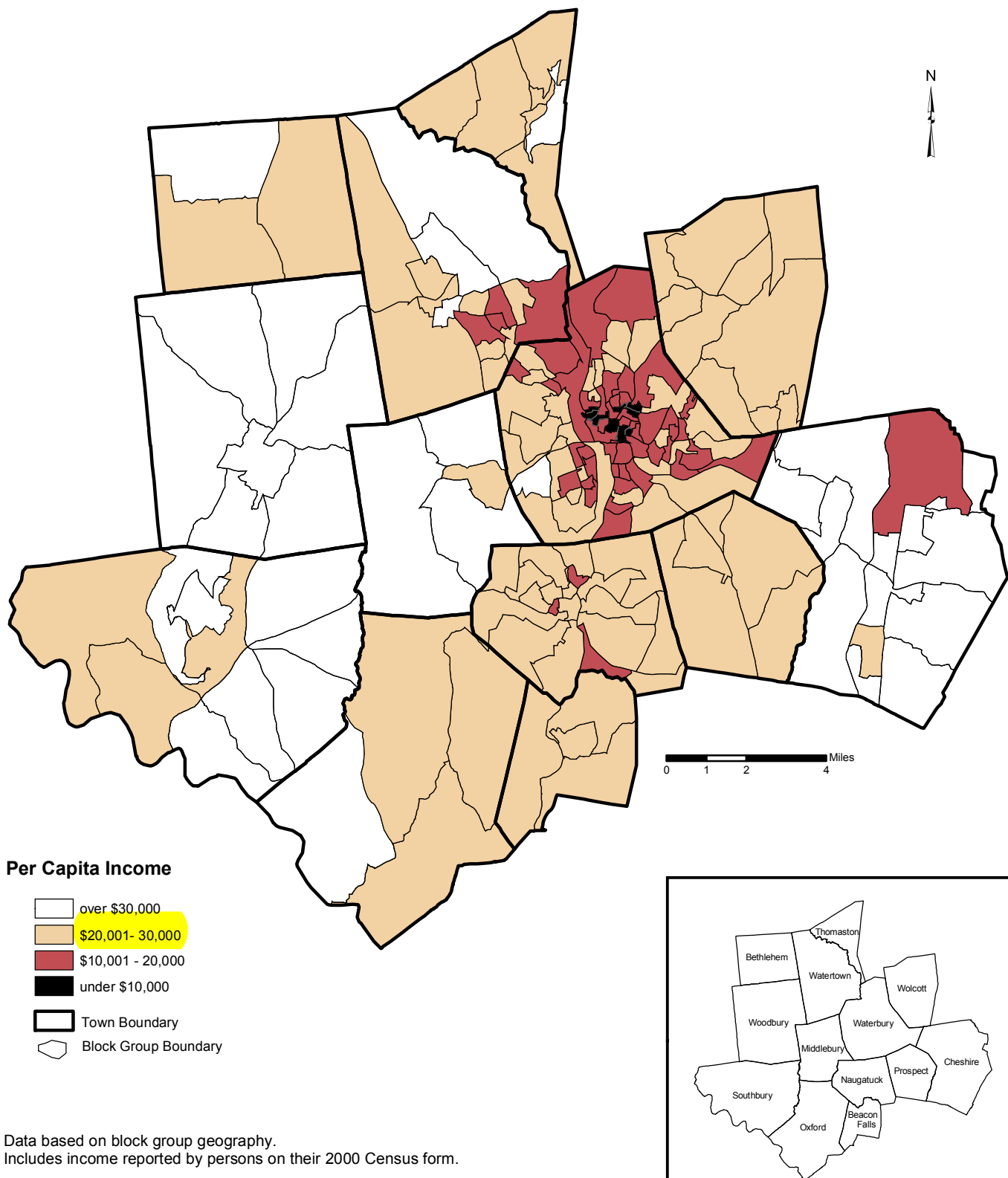

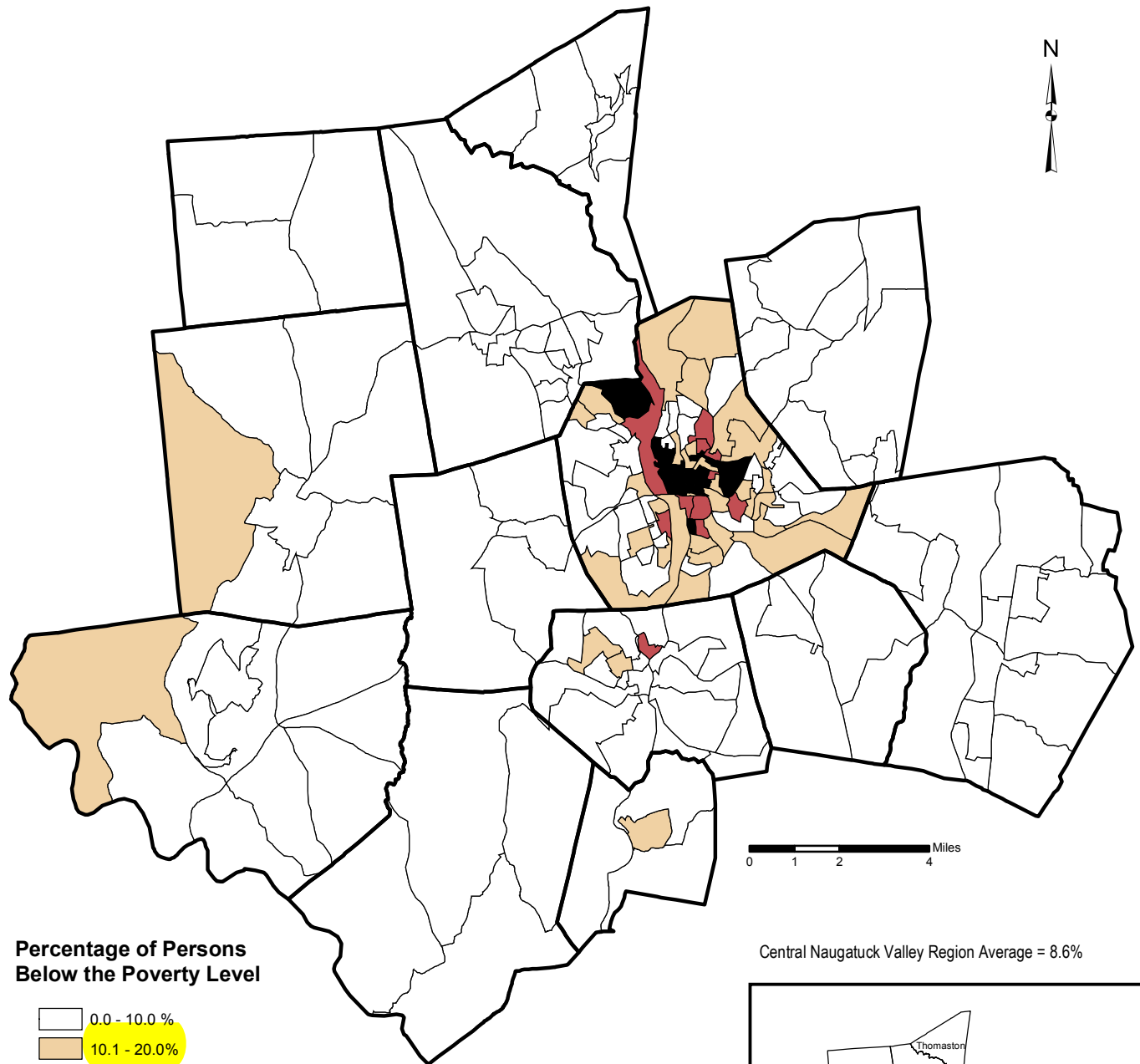
Figure I-G1. Per Capita Income, by Block Group: 2000



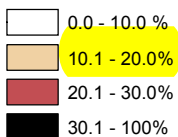

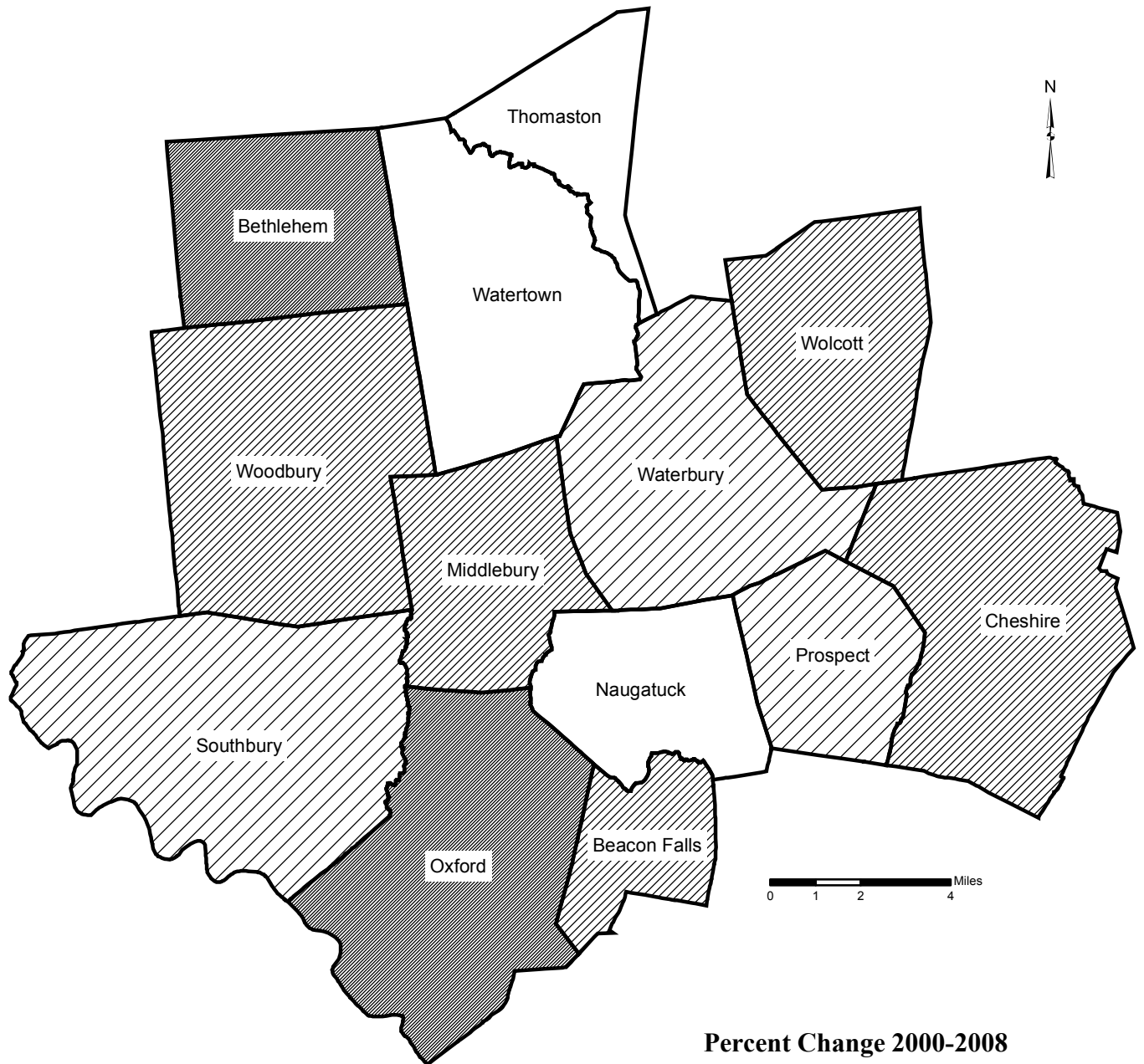

Percent Change 2000-2008

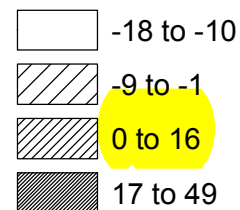

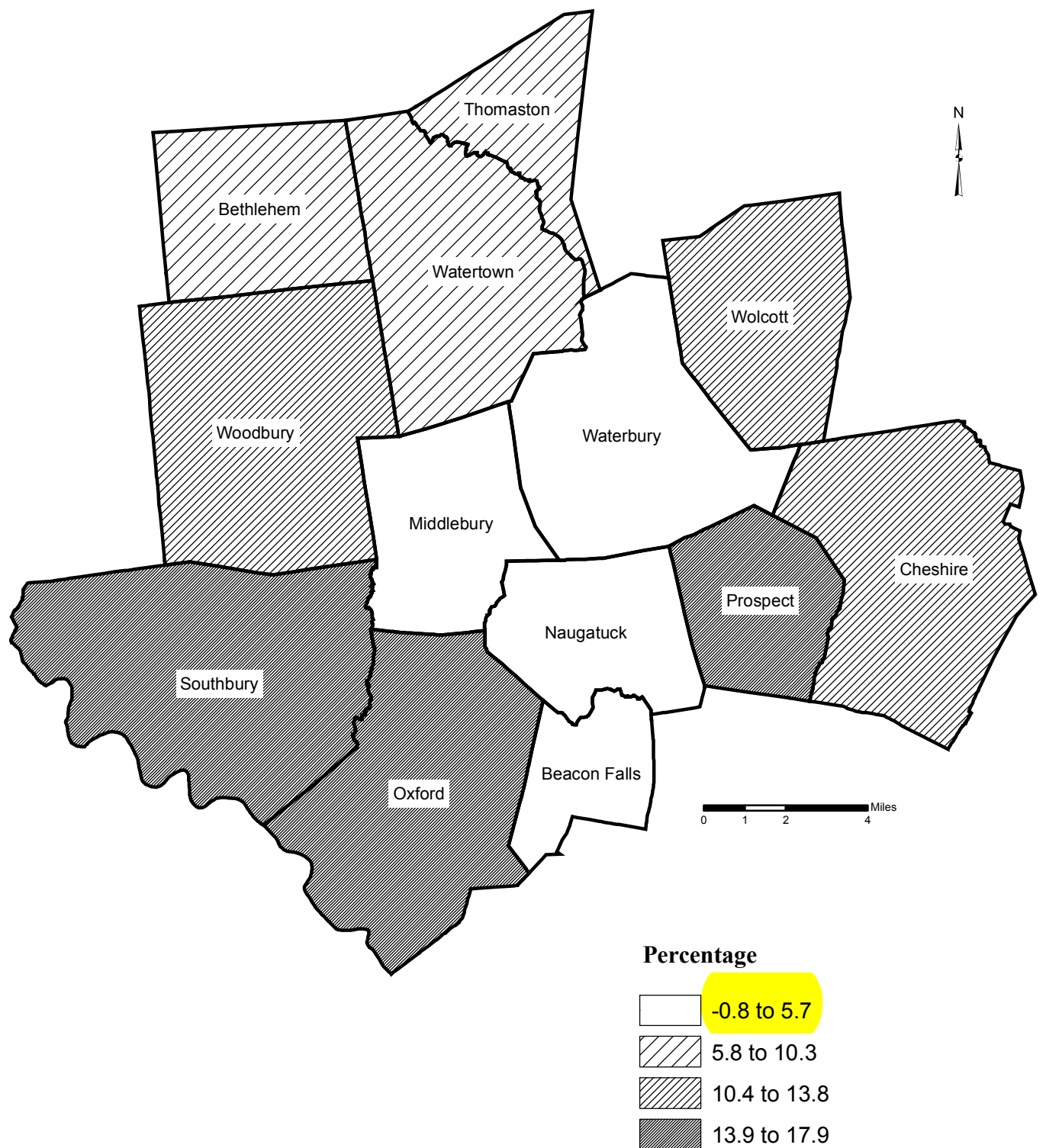

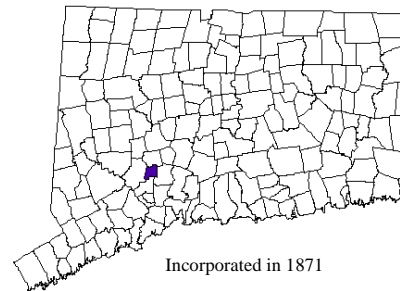
