Wesley Vercosa – on behalf of Craft Cured Consulting LLC

131 Summit Street, Unit C, Newington CT- Wesley Vercosa - There are entities such as Crafted Cured Consulting that can help local government with these regulations – The time of marijuana madness is behind us. Revenue that can be generated is 3% of gross revenue of sales.

Joanne Delenick, 243 Bethany Road – It is not known what the damages to the community will be. There is not going to be a Purdue family to sue.

HR: In regard to revenue, the working group felt that the revenue, after investigating is not what we expected This is a big issue of the town, I'm not sure how many are in favor.

MB: Comments should be directed to Governor Lamont. He legalized marijuana. We are looking at how to make this revenue produce work for our Town. The merits of debating marijuana oxycontin, that is not for this Commission. Seymour will have a facility. Naugatuck will. Even if we keep it out of Beacon Falls it will be in surrounding towns.
