The attention of bidders submitting proposals for the above-referenced project is called to the following addendum to the specifications.

September 18, 2019

Q: In Section V. Submission of Fee Proposal, the table required for bid submission to insert pricing uses a multiplier of 1,550,000 Gallons. However, in part ii. of this section, Sludge Calculations, 1,500,000 gallons is referenced as the multiplier. Could the town please clarify which gallon multiplier should be used to fill in the 3-Year Total Sludge Cost.

September 18, 2019

A: The 1,500,000 gallons that the Town listed in Item ii in Section V "Submission of Fee Proposal" located on Page 9 is correct. The 1,550,000 listed in the chart at the top of this section under the "Gallon Multiplier" column was incorrect. A corrected Section V is presented on the following page:

V. SUBMISSION OF FEE PROPOSAL

The Bidder shall complete pricing for all years as follows:

- i. Bidders shall enter unit costs for all years. In the event that there is a discrepancy between the unit price and the total price extension, the unit price will govern.
- ii. Sludge Calculations: The unit costs each year should be entered and inflation and/or cost escalations between each contract year should be reflected. 1-2% solid concentration should be assumed over all contract years and included in said calculation. These three years shall then be averaged to determine the average unit cost by year. The 3-year average unit cost shall be multiplied by 1,500,000 gallons to determine the total 3-year sludge cost. This 1,500,000 gallons figure was selected based on an average of the 5 years listed in Item #3 (above) and rounding down to the nearest hundred-thousand due to steady efforts of sludge reduction that the WPCF/WWTP continues to pursue.
- iii. Unit costs shall include the total cost to the Town. The Town shall not be assessed additional fees.
- iv. The total annual bid amount is a not to exceed amount; the Town will be billed based on actual sludge gallons picked up and transported.
- v. The annual gallons of sludge is an estimate and is not guaranteed. If Beacon Falls WPCF does not meet the gallon multiplier above, the bidder will not be compensated for the difference.
