SM – we think that the main message center should have a large rock with flowers or something under the sign to prevent people from wanting to run the sign down with a vehicle. BE – Steve sent me some photos from the park, do you want to speak about that? SM – yes, I met with a resident, Bernie Molleur, he has some original ariel views of the park. He wants to turn them over to the town, but he does not want them to get lost or forgotten. Al - we can even add them to the website. SM – I sent in a report for the BOS meeting with the work that has been completed.

## b. Pent Road Recreation Complex

SM – tennis courts have reopened, and we discussed opening the basketball courts. For now, they will remain closed. We removed the bleacher's off premises due to COVID. Al and I have been working on Playground signage. We met with the company that put the playscape in and have some safety concerns. We are still working on making the playground safe. Al – we met with CIRMA who did the initial inspection of Pent Road and we also did an inspection at Matthies. We are still waiting on the report. Once we get the report, we will meet with Gerry and decide on how we are going to proceed.

c. <u>Riverbend Park</u>

BE – have not heard anything on this. SM – other than brush clearing and routine maintenance, nothing besides that. AI – I have been checking compliance on licenses and most are compliant.

BE – if someone else wants to volunteer you can contact Selectman Krenesky. Al – just as an FYI, I have sent out reminders via the website about trail etiquette and social distancing. MF – the firework and concert money, can we use that for other stuff so that we do not use it? BE – I am not sure, but I will check with Finance. MF – we may be able to use some of that to donate to the anniversary fund.

## f. <u>Toby's Pond</u>

SM – on Friday, we started getting in there with the brush tractor. The Knotweed has gotten away from us and we are working to get it under control. Al – I did patrols and at Toby's I am finding a lot of watercraft that is not permitted. I have been checking for kayakers for PFD's.
