Naugatuck Valley Health District Schedules Seasonal Flu Clinics

The Naugatuck Valley Health District (NVHD) will offer influenza vaccine clinics to residents of Ansonia, Beacon Falls, Derby, Naugatuck, Seymour and Shelton during the months of September, October and November. All residents are welcome to any of the clinics listed below, and appointments are not necessary. Clinics will be held at the following locations:

Wednesday	September 27 th	9:30AM-12PM	Shelton Senior Center
Monday	October 2 nd	10AM-12PM	Beacon Falls Senior Center
Thursday	October 12 th	10AM-1PM	Seymour Community Center
Friday	October 13 th	9-11AM	Naugatuck Senior Center
Tuesday	October 17 th	11AM-1PM	Derby Senior Center
Thursday	October 19 th	10AM-12PM	Ansonia Falls Senior Center

Additional clinics will be available by appointment at Naugatuck Valley Health District, 98 Bank Street, Seymour, CT 06483. Children (6 months and older) needing flu shots will be accommodated by appointment at regularly scheduled immunization clinics at the district office in Seymour.

The Health District accepts the following insurances; Aetna, Cigna, ConnectiCare, Anthem Blue Cross/Blue Shield, Medicaid, Medicare Part B and United Healthcare. There is no copay to those who have insurance. Those who are eligible should bring the proper insurance cards and ID. Save time and bring a photo copy of both! The cost of the flu vaccine for those who do not have insurance is \$35 for the quadrivalent vaccine and \$70 for the high dose vaccine for those 65 years and older. Acceptable forms of payment are cash, check, or credit card. All clinic attendees should wear loose fitting clothes with short sleeves.

Any homebound persons who cannot attend any of the clinics may contact the Health District at 203-881-3255 ext. 107 to make arrangements for a nurse to administer the vaccine at home. Such individuals should have permission from their physicians for the influenza vaccine and have insurance through the above noted insurers.

Clinic dates may be added or revised.
