**1. Call to Order**

Chairman Jeff Smith called the meeting to order at 7:38 P.M.

**2. Comments from the Public**

J. Smith asked three times if there were any comments from the public and there was none at this time.

**3. New Applications**

There were no applications received for tonight's meeting.

**4. Public Hearing**

There was no Public Hearing held and no discussion at tonight's meeting.

## **5. Approval of the Minutes**

### **a. Mario Trepca, 113-115 South Main Street**

J. Smith indicated that the tenant had previously contacted him to have the CO signed. J. Smith had informed the tenant that he will not be signing the CO until the \$4,000.00 sewer user fee is paid by the landlord. As of today's date, the fee has not been paid by the landlord.

J. Smith and the Members mentioned again that there is a concern with something being dumped down the sewer lines from the distillery and getting to the sewer plant. The Members also agreed again that the Board needs to be informed of what is going to be used during the processes and if it will be harmful to the lines and to the sewer plant.

### **b. Nitrogen & Phosphorous Removal**

Dave Prickett was not present at tonight's meeting. J. Smith indicated that D. Prickett was unable to attend tonight and would attend either the October or November meeting. J. Smith noted that D. Prickett mentioned that he would like to speak with the Selectmen first.

### **d. Sewer User Fee Study**

Dave Prickett was not present at tonight's meeting. J. Smith asked to keep this agenda item on for next month.

J. Smith mentioned that there needs to be a change to the permit requesting a drawing for the as-builts. The change has not been done as of yet and will be worked on.

R. Pruzinsky indicated that Skokorat Road was repaved and changed grade rings were changed due to damage over the years or rotted out. R. Pruzinsky mentioned that there is a manhole just past Lantern Ridge that isn't sealed and filled with water. After a brief discussion, J. Smith asked for a motion to give Nafis & Young permission to resolve the issue with damaged manholes.

Motion to give Nafis & Young permission to resolve the issues on Skokorat Road with damaged manholes: **Motion made by R. Pruzinsky and seconded by R. Komar; no discussion; all ayes.**
